5.	Discussion with Neil Shuttleworth	Several directors went out with Neil this afternoon to see the proposed trail adjustment. Walked Mistletoe to Meander to Roller Coaster to Juniper out to the opening by Four Mile Lake. There is an arch zone there to be capped, with no disturbance to the site. This route has better grades. Will reroute part of the trail to get around the steep section. Board to consider reclaiming the steep section as a future project. Some gravelling will be done around Gateway.  Randy moves to change approved location from Meander to Mistletoe, include the small realignment and gravel trails as needed as proposed by Neil. Seconded by Tara. Carried

6a	Trails	i. Loops Lake Proposal – Tara presented a map with three trail loop options: Gateway, 2800m return, Lakes Loop (north), 8200m return and Lakes Loop (South) 6400m return to the COTR parking lot. Can put maps in hotels. For website, use georeferenced maps. Next step is to figure out a design for the markers. Walter to approach CBK	

- chamber of Commerce tourism. Motion to approve loops as proposed by Tara moved by Randy, Kathleen seconded. Carried.
- ii. Trails approved for Wildhorse in the spring is almost complete. Beginners luck not a great name. Neil conversed with FN, who suggested Pilliset (wife of Chief Isadore).
- iii. Future Trail Building aim is to encourage more people to use the trail head at Isadore.
- Expresso is a downhill run, coffee grinder a climb, and green chicken extension (black diamond) a downhill to rail grade. Section 57 approval needed from Lisa. More detailed layout to be completed. Motion to approve adding the Expresso, Coffee Grinder and Green Chicken extension trails to the plan by Randy, Seconded by Joseph. Carried.
- iv. Trail Maintenance update Tara is starting a database. Start to populate in the spring. There may be CBT money available for maintenance. Signage and upgrades done for Bonehead and Ewok.
- v. Weed Treatment plan Deferred
- vi. Endowment Fund (Community
  Foundation. Use when we want to look at longer term sustainable funding. Need \$10,000 to start. Board would have to decide to pursue as sit can't be touched. 2.5% return (after cuts taken by others). Can use funds for whatever you want or direct to a specific area. Needs to be a registered charity or partner with someone who is for tax receipts. Someone on Board would have to take on. Columbia Outdoor School could take the role on as a flow through.
- vii. Counters Lisa put out 6 counters in the spring. Interested in winter use. Lisa to collect the data for this fall.
- viii. Winter grooming would like to know what is planned. Deferred.

Informal Survey of public users near the COTR by Walter: <ul> <li>major cleanup is needed;</li> <li>want shorter stumps, or none.;</li> <li>leave more big trees standing;</li> <li>what is the effect on wildlife?
